

Reporting Form Instructions

Attached you will find a copy of the 2022 Safe Environment Certification form that is required every year, from every parish in the Archdiocese of Denver. The questions on this certification form are taken from the USCCB annual audit questionnaire.

Religious Education programs in the Archdiocese of Denver will be providing VIRTUS *Teaching Safety — Empowering God's Children* Lesson 2 – Safe Adults, Safe Touches and Special Safe Adults for the 2021-2022 program year. You may do as many additional lessons as you have time for if you wish (Archdiocese schools will be providing Lessons 3 and 4 for the 2021-2022 school year.)

Parent/guardian led lesson plans are available for home catechesis programs.

Online reporting through Virtus is available, with your pastor's approval. If you use this option, please <u>Create an</u> <u>Acknowledgement</u> (click the button) form from Virtus and email it to us when input is complete.

Minors: <u>FORM A</u>: The Charter for the Protection of Children and Youth requires that all children and youth in all religious education programs in the Archdiocese be provided safe environment training. <u>Please offer these classes in the fall</u> so that attendance, opt-out and not trained totals as of December 31st, 2021, can be reported by February 28th, 2022. <u>Do not include Catholic school children on this form.</u>
